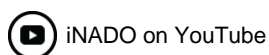
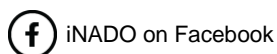

### Outstanding 2017 Membership Fees

Unfortunately, up to date five Member NADOs have not paid the membership fees 2017. As a consequence, upon approval by the iNADO Board of Directors at their next meeting, these organisations will be suspended and not be able to enjoy any of the benefits of the membership in 2018 (per article 25.3\* of our Articles of Association).

By our new policy for outstanding payments, membership can be terminated after two years in arrears if there are not sufficient mitigating circumstances that explain it.

Only by being up-to-date with your membership fees, iNADO can provide valuable service to all member organisations as they deserve it.

\*25.3. Membership will be suspended for so long as an annual subscription remains unpaid beyond the due date. During any suspension, the member shall not enjoy any rights attaching to membership of the company,

including the right to nominate any person as a director or to participate in and vote at general meetings, but shall otherwise remain subject to the provisions of these articles.
