### 2019 World Conference on Doping in Sport

The World Conference in Katowice was a great opportunity to meet colleagues and friends of the anti-doping community. The Board of iNADO used the conference to reiterate our goal to make the anti-doping system better.

#### Intervention of iNADO Chair, Michael Ask

*(...) NADOs conduct something like 75-80 % of all anti-doping activities in the world. We regard ourselves as an important stakeholder to WADA. I therefore welcome the fact that WADA over the past months has reached out to iNADO and signaled a will and a desire to cooperate closer, especially on how we together can ensure that the level of the anti-doping activities in all corners of the world meet a certain standard (...). #### Intervention of Vice Chair, Herman Ram (on behalf of Doping Authority Netherlands)

*(...) But notwithstanding the fact that all changes have a logical background, it remains a fact that expanding our set of rules creates a paradox. Experiences in the field lead to new rules because we want to cover all aspects of doping, a complex monster with many faces. But both the implementation of the rules, and educating athletes and athlete support personnel about them, are not getting easier. ### **2019 iNADO CEO Forum in Katowice (Nov. 4)**

45 Member Organisations participated in the iNADO Forum in Katowice to provide final input on the strategic plan which will be valid for the next few years. The concept is based on the solid foundation that iNADO has built in the past seven years, but the input received will allow us to serve our members better by promoting:

- Advocacy: be an influential, international voice
- Best practices: seek, share and promote best practices
- Capacity building: a supportive international member community.

Group discussions held during the CEO Forum in Katowice intended to highlight challenges and opportunities to which iNADO needs to pay special attention. The comments received turned mainly around the following four topics:

- Sharing information
- Technical support
- NADO Independence (institutional, operational and financial)
- NADO Representation
