It has been an extraordinary first half of the year and iNADO would like to acknowledge the tremendous efforts our members have made to adapt to the challenges caused by Covid-19. It has been great to see that many ADOs, especially NADOs, have continued to actively move their anti-doping programmes forward during this time.

iNADO had hoped to meet many of you in Lausanne during our Workshop and WADA's annual Symposium in March. This would have given us the opportunity to review some of the items that were going to dominate the anti-doping calendar: the implementation of the Code 2021, the introduction of two new International Standards with special attention to the Standard of Education, Sanctioning Substances of Abuse in 2020, testing strategies for the 2020 Olympic and Paralympic Games, the expansion in the use of new scientific tools, etc.

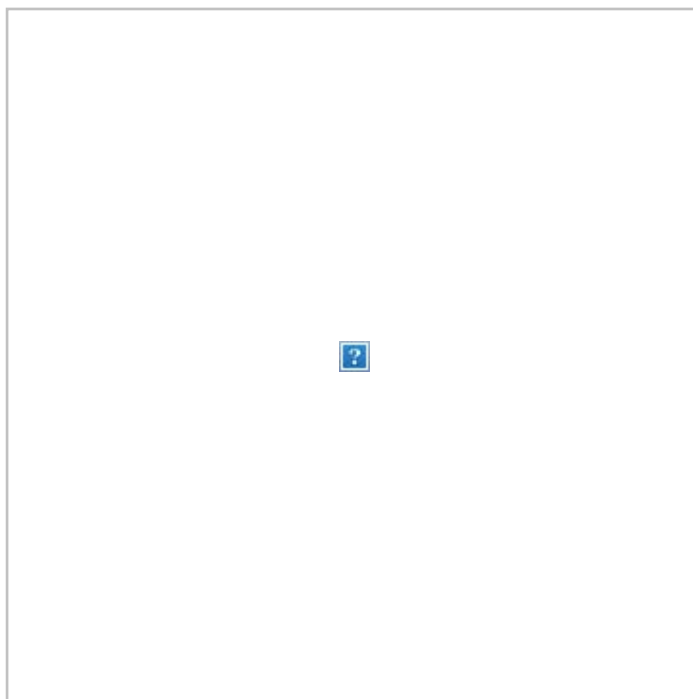

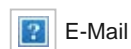
