1. Welcome and Confirmation on the Convening of the Meeting and Entitlement to Pass Resolutions

The Chair, Anders Solheim, welcomed members to the 2025 iNADO General Assembly (AGA), and informed all attending that the General Assembly will be conducted in accordance with the iNADO Rules of Procedure (Version 10 June 2022). He apologized Board members Tony Josiah and Li Zhiquang for not being able to attend the Meeting.

Thirty-nine (39) member organizations were present, and the Chair declared the decision-making capacity of the General Assembly (at least half of the 67 members).

2. Approval of 2024 General Assembly Minutes

The Minutes of the 2024 General Assembly were approved (36 in favor, 0 against, 0 abstentions).

After approval by the 2024 General Assembly, the required changes to the iNADO Constitution were submitted to the District Court of Bonn, with a request to amend the iNADO Constitution. The amended Constitution became effective on 07 June 2024. This Constitution is available from the iNADO Website (section "Governance").

3. Report of the Governing Board

Members received an oral report from the Chair of the Board, Anders Solheim. A more detailed written report had been circulated in advance.

The Chair thanked the outgoing Board, all fellow Board members, and Dr. Andrea Gotzmann for their contributions throughout 2024.

4. Report of the CEO

Members received an oral report from Dr. Andrea Gotzmann, interim CEO April – November 2024, and Dr. Peter Van de Vliet, new CEO as of December 2024. A detailed written report had been circulated in advance

5. Approval of the Financial Report 2024

Members received the Financial Report 2024 in advance.

The Financial Report 2024 was approved (39 in favor, 0 against, 0 abstentions).

6. Approval of the Budget 2025


Members received the Budget 2025 in advance.

The Budget 2025 was approved (39 in favor, 0 against, 0 abstentions).
